The Allen Co. SWCD and its committed partners are working extensively under a Contribution Agreement with NRCS that focuses on urban and small farms in the Indiana portion of the Western Lake Erie Basin (WLEB). A small farm is considered a farm that produces less than \$250,000 of gross revenue annually.

The District has begun to offer community education through events and workshops like the Coffee and... Series and Live from Avilla. The project provides technical assistance and guidance to small and urban farms in the WLEB and community support for existing small farms and/or community gardens.

Subcommittee groups have been formed to execute smaller projects and begin to develop materials. The subcommittee on technical assistance is underway with discussion farmer to farmer mentoring and ways to reach small and urban farmers. The education committee is set to meet February 3rd.

#### AUGLAIZE-FLATROCK WATERSHED MANAGEMENT PLAN

We are in the process of selecting critical areas. Critical areas are defined as areas where watershed management plan implementation can remediate nonpoint source pollution sources in order to improve water quality.

Steering Committee members are processing research data to determine what areas of the Auglaize/Flatrock watershed should be identified as critical. They are considering land use, water quality, habitat, and flooding conditions to help them make their decisions.

#### **USGS-GLRI EDGE OF FIELD PROJECT**

Currently, United States Geological Survey (USGS) and the Allen SWCD work collaboratively to sample water in Harlan, Indiana. The systems are built on the land of cooperating landowners and farmers, at no cost to the farmer. This is funded through the Great Lakes Restoration Initiative grant awarded to the USGS.

USGS hydrologists in Indiana are studying the Black Creek watershed in eastern Allen County, a tributary to the Maumee River and ultimately Lake Erie. The objective is to conduct intensive water quality sampling to monitor the effects of agricultural Best Management Practices in an effort to reduce nutrient and sediment loading into Lake Erie.


