## 11rban AGRICULTURE



The Allen Co. SWCD and its committed partners are working extensively under a Contribution Agreement with USDA-NRCS that focuses on urban and small farms in the Indiana portion of the Western Lake Erie Basin (WLEB).

#### What's Available?

- · Free soil sampling
- Guidance for obtaining and implementing nutrient management recommendations
- Technical assistance like site visits, identification of resource concerns
- Mentorship
- Educational experiences like workshops, field days, bus tours of local facilities, pontoon boat tours of local waterways, and scholarships for attending educational events.

#### Who's Eligible?

Urban farms, small farms, and community gardens within the Indiana side of the Western Lake Erie Basin (WLEB) are eligible for the Urban and Small Farms Program. A small farm is considered a farm that produces less than \$250,000 of gross revenue annually. Use this website to determine if your property is in the WLEB: https://bit.ly/3aCqCSQ.

So far, we've collected soil samples from over 15 farms and gardens, and we've provided technical assistance to several operations. We've had several educational events including the "Coffee and" webinar series and Live from Avilla, a demonstration of converting planting equipment to a no-till system. #### AUGLAIZE-FLATROCK WATERSHED MANAGEMENT PLAN

The Allen County SWCD has hired Consultant Bruce Cleland with Tetra Tech to assist with the development of the Watershed Management plan. Bruce will summarize water quality monitoring data from sites in the Flatrock watershed, focusing on the spatial and temporal differences of nutrients, sediment, and bacteria. He will also develop flow estimates for each of the District's monitoring sites. Patterns will be examined relative to available stream flow and precipitation data, as well as relevant USGS gage information.

Bruce will also prepare a supplemental assessment report that summarizes water quality data. This technical analysis will also consider streambank condition, windshield survey results, tillage transect data, and available stream cross-section / flow measurements.

We're excited to have Bruce on the project and look forward to incorporating his assessment document into appropriate sections of the Flatrock - Auglaize WMP.
